## LINE 1. NAME AND MAILING ADDRESS

- a. NAME OF OPERATOR (PERSON OR CORPORATION) If the name is preprinted, check the spelling and correct any error. In the case of an individual, enter the last name first, then the first name and middle initial. Partnerships must enter at least two names, showing the last name, first name and middle initial for each partner.
